


INSTRUCTIONS

1. **INTENDED USAGE:** Knee kickers should be used for positioning carpet, hooking carpet on tack strip, and light stretching in cramped areas. Use a power stretcher for "stretching-in" rooms, since hard kicking can injure the user and damage the carpet.
2. **LENGTH ADJUSTMENT:** A press of the buttons allows the choice of 4 length adjustments from 22 3/4" to 26". Always check that both sets of buttons are engaged before beginning your kicking.
3. **PIN PENETRATION:** The pin adjustment dial gives a visual reference of pin depth. Set the depth to the approximate carpet thickness. In use, the long pins should reach through the pile into the carpet backing, but not through the backing.
4. **BUMPER ROTATION:** The bumper can be turned for an even distribution of wear.
